

## **Standard Terms and Conditions of use of the portal: masterView.dk**

The following terms and conditions apply to access to and use of Profort A/S' internet portal "masterView" for programming and monitoring Profort A/S' multiGuard and Piccolo devices.

### **1. masterView**

1.1 masterView is a professional tool for programming Profort A/S' multiGuard and Piccolo products via a server that is made available to Profort A/S' customers. The traffic is primarily data, which is settled between the customer and their telecommunications provider. Profort A/S disclaims any responsibility for any overconsumption in connection with traffic on the SIM card.

1.2 Access to masterView only applies to products supplied by Profort A/S.

### **2. masterView/login page**

2.1 To use the portal, it is necessary to register with your name, address and e-mail address. The information is stored inaccessible to third parties, but Profort A/S reserves the right to use the information in marketing purposes.

2.2 All data are stored by and at masterView.

All processing of personal data is carried out in compliance with the Personal Data Act. You can contact Profort A/S as the data controller if you want information about which data is processed about you, or if you want the information deleted or corrected.

2.3 Your access to masterView's login page is personal and confidential. Passing on your access (username/password) to a third party is not recommended.

If you hand over your access to masterView's login page, this is done at your own risk. Profort A/S recommends that you only do this with prior written agreement with this third party.

2.4 It is not permitted to attempt or gain access to masterView's login page without a legal username and password.

### **3. General information and material from masterView.**

3.1 The information entered is personal and confidential. masterView will not sell or disclose such information to third parties without your prior consent, unless required by law.

### **4. Disclaimer**

4.1 Information on masterView's login page is provided without any express or implied guarantee for the accuracy or completeness thereof.

4.2 In communication between masterView and you, Profort A/S has no liability if the information is changed or distorted during transmission or if unauthorized persons gain access to it.

4.3 If a link is provided to a third party's website, this is done with no liability for Profort A/S for the content of the page linked to.

4.4 masterView can in no case be held liable for the use of masterView's login page, including for loss of income, operating loss or loss of data, operational disruptions or similar losses.

## **5. Change of conditions**

5.1 Profort A/S is entitled at any time to change the content of masterView without prior notice.

5.2 Profort A/S may revise these terms and conditions at any time without prior notice.

## **6. Other rights**

6.1 Logos, trademarks, images and graphics, etc. on the masterView login page belong to masterView and may only be used with prior permission.

6.2 Unauthorized copying, distribution or public performance of the masterView login page or parts thereof is in violation of copyright law and may result in civil as well as criminal sanctions. It is also not permitted to remove notices on the masterView login page or material available thereon regarding copyright or similar.

6.3 Downloading and other digital copying of the website content or parts thereof is only permitted for personal, non-commercial use, unless otherwise agreed with masterView.

6.4 masterView reserves the right to remove information on the masterView login page, as well as to close the masterView login page, at its sole discretion and without notice.

## **7. Subscription terms and use of masterView**

7.1 Use of masterView setup is basically free. If the function 'masterView forwarding' is used to send SMS messages, each SMS will be billed at a daily rate per SMS. The amount is billed to the same customer who has the subscription to masterView MAP.

7.2 Access to masterView MAP requires the use of a Profort SIM card, Business Small or Business Large subscription or a subscription for masterView MAP. If the customer's own SIM card is used, a subscription for masterView MAP must be taken out within 30 days.
