

Standard Terms and Conditions for Piccolo Server Software

The following terms and conditions apply to access to and use of Profort A/S' Piccolo Server software for alarming and monitoring of art objects and climate measurements in museums, galleries and areas with large visitor flow.

1. Piccolo Server software

1.1 Piccolo server software is a professional tool for programming, alarming and monitoring of art objects and climate measurements in museums, galleries and areas with large visitor flow. The Piccolo Server software is installed on a server provided by the customer or is delivered pre-configured by Profort A/S.

1.2 Piccolo Server software may only be used in connection with Piccolo equipment supplied by Profort A/S. The exception is the server where the Piccolo Server software is installed.

2. Piccolo Server software

2.1 To use the Piccolo Server software, it is necessary to register detectors and their information. The information is stored on the Piccolo Server software server and is inaccessible to third parties if the customer's network ensures this.

2.2 All data is stored by the customer.

All data created in the Piccolo Server software should be done in compliance with the Personal Data Act, but is the customer's responsibility.

2.3 Access to the Piccolo Server software is personal and confidential. Passing on your access (username/password) to a third party is not recommended.

If you pass on your access to the Piccolo Server software, this is done at your own risk. Profort A/S recommends that you only do this with prior written agreement with this third party.

2.4 It is not permitted to attempt or obtain access to the Piccolo Server software without a legal username and password.

3. General information and material from the Piccolo Server software.

3.1 The information entered is personal and confidential. Piccolo Server software does not sell or pass on such information to third parties under any circumstances.

4. Disclaimer

4.1 Information on the Piccolo Server software is provided without any express or implied guarantee for the accuracy or completeness thereof.

4.2 In the case of communication between Piccolo Server software and any API interface, Profort A/S has no liability if the information is changed or distorted during transmission, or if unauthorized persons gain access to it.

4.3 If a link is made to a third-party software, for example through an API interface, this is done without any liability for Profort A/S for the content of the page that is linked to.

4.4 Piccolo Server software can in no case be held liable for the use of the Piccolo Server software, including for loss of income, operating loss or loss of data, operational disruptions or similar losses.

4.5 If Piccolo Server software is installed on the customer's own server, Profort A/S accepts no liability for the operation of the Piccolo Server software.

5. Change of conditions

5.1 Profort A/S is entitled at any time to change the Piccolo Server software without prior notice

5.2 Profort A/S may revise these conditions at any time without prior notice.

6. Other rights

6.1 Logos, trademarks, images and graphics etc. on Piccolo Server software belong to Profort A/S and may only be used with prior permission.

6.2 Unauthorized copying, distribution or public performance of Piccolo Server software or parts thereof is in violation of the copyright and may result in civil as well as criminal sanctions. It is also not permitted to remove notices on Piccolo Server software or material available on it regarding copyright or similar.

6.3 Downloading and other digital copying of Piccolo Server software content or parts thereof is only permitted for personal, non-commercial use, unless otherwise agreed with Profort A/S.

6.4 Piccolo Server software should be updated at least every 18 months. If this does not happen, Profort A/S cannot guarantee the functionality of the Piccolo Server software and the terms within this document.

7. License terms and use of Piccolo Server software

7.1 Use of Piccolo Server software requires a license purchased from Profort A/S, based on the number of detectors created in Piccolo Server software. The license is solely associated with the individual Piccolo Server software installation, and cannot be transferred or resold to a third party.

8. Invalidity

8.1 If any part of these terms and conditions should be considered unlawful or invalid and thus unenforceable, this shall not affect the validity and enforcement of the remaining part of the terms and conditions.

9. Governing Law

9.1 These terms and conditions are subject to Danish law.
